

#### **UNDERGRADUATE PROGRAMMES**

In our undergraduate programmes we are committed to academic excellence, have an innovative approach to the teaching of law and aim to offer high-quality instruction in law subjects.

The faculty offers the following qualifications across its three campuses:

Bachelor of Arts in Law (BA in Law): Allows the student to acquire knowledge of the South African legal system, private law, constitutional law and customary law. The subject groups Private Law, Public Law, Mercantile Law and Criminal and Procedural Law exist in order to assist in the academic administration of the programme. If you hold this degree, you can enrol for the LLB degree. (Potchefstroom and Vaal Triangle Campus)

Bachelor of Commerce in Law (BCom in Law): Recommended to students who have a dual interest in law and business. This degree complements the LLB, as it provides a broader perspective on commerce, in particular. The subject groups in a BCom in Law are exactly the same as in the case of the BA in Law, the only difference being that modules relating to commerce are also included. (Mafikeng, Potchefstroom and Vaal Triangle Campus)

Bachelor of Laws as first degree (LLB): The difference between the LLB, and other law degrees is that generally LLB students spend their

entire course studying the law, while students in other law programmes also spend time studying modules outside of law. This LLB degree programme is also offered as a second degree for students already in possession of a BA in Law or a BCom in Law. Career opportunities includes working as an attorney, advocate, state prosecutor, magistrate, working in government, the commercial sector as legal adviser. (Mafikeng and Potchefstroom Campus)

Extended Bachelor of Laws as first degree (LLB): The differences between the four-year LLB and the extended LLB are that the law modules are spread over a period of five years rather than four and that in the first year specific modules are included, to bridge the gap between school and university, and to enhance the skills needed to be able to successfully complete the degree. The career opportunities are exactly the same as for the four-year LLB degree.

#### COMMUNITY LAW CENTRE ON THE MAFIKENG CAMPUS

At the community law centre we are committed to provide quality legal assistance to the community, primarily to indigent people who qualify for free legal assistance. This service is combined with practical legal training for students, who are empowered to apply their acquired legal skills. This specialised unit is principally responsible for our community service and outreach programmes.

The centre provides free legal aid to indigent people in the communities surrounding Mahikeng and offers professional and technical assistance to paralegal offices and advice centres in the province. The centre also trains candidate attorneys for admission as attorneys.

#### LAW CLINIC ON THE POTCHEFSTROOM CAMPUS

The law clinic is involved in a number of projects concerning free legal services, community outreach, and capacity-building programmes, as well as advisory services. The law clinic operates in the provinces of North-West and Mpumalanga. It offers practical legal training to students, short courses for lawyers and paralegals, and training to members of the local communities. The law clinic also provides free legal services to poor and vulnerable people in the above provinces. It further provides advisory services to members of the community to promote a "rights-based" society, and to, convice them that, instead of taking the law into their own hands, they should use the law to enforce their rights.

#### SHORT LEARNING PROGRAMMES

Any member of the public may enrol for any of these courses, should they comply with the admission criteria for the specific programme. All programmes have been approved by the NWU Institutional Committee on Academic Standards. The programmes comply with the prescribed 40hour formal training and standards set by the court-annexed mediation rules as one of the requirements for registration as a mediator. We will gladly offer any of these as an in-house training programme adapted to your particular needs. Programmes offered includes:

#### Research Unit for Law, Justice and Sustainability

This unit addresses developmental and legal challenges in South Africa. # DST/NRF South African Research Chair in Cities, Law and **Environmental Sustainability (CLES)**

The objectives of CLES are to develop a new theoretical framework for the future description, analysis and development of urban law and governance in South Africa with a focus on environmental sustainability; to research and analyse the legal foundations of urban development and the legally justifiable expectation that governments (including the South African government) should create communities that are safe, sustainable, resilient and inclusive; and to equip a new cohort of highly-skilled and connected young legal scholars who can spearhead this work in academia and legal practice, in South Africa and beyond.
