#### UPDATE ON THE STUDENT VOTER PARTICIPATION DURING THE 2023/24 SCC AND SRC: DSO VOTING PERIOD

Dear students

This notice serves as an update on the notices published on 26 and 28 August 2023, [available here](#).

On 29 August 2023 at 10:00, the voting period for the 2023/24 SCC and SRC: DSO Election concluded.

Upon the conclusion of the voting period, the University conducted a preliminary analysis of the student voter participation data for complete voting period, i.e., voting conducted between 10:00 on 25 August 2023 to 10:00 on 29 August 2023.

The analysis revealed the following preliminary insights pertaining to student voter participation:


*\*Non-eligible voter participation referenced above refers to, amongst others, student voter participation on a campus where the student is not a registered student voter.*

*\*\*Eligible student voter participation referenced above refers to preliminary compliant student voter participation, subject to the period of objections as provided for in the Institutional Rules on Student Governance (2023) referred to hereunder.*

Student voters must take note that the data provided above remains preliminary data which will be subjected to auditing processes by NWU Internal Audit and the appointed external auditor. Therefore, a variation between the data reported above, the voter dashboard published online, and the final audited voting results may occur.

In accordance with paragraph 11.2.4 of the Institutional Rules on Student Governance (2023)<sup>1</sup>, the preliminary list of elected candidates will be published by the ISEC at 10:00 on 30 August 2023, whereafter the 48-hour objection period will commence in accordance with paragraph 12.1 of the Institutional Rules, guided by the electoral schedule, [available here](#).
