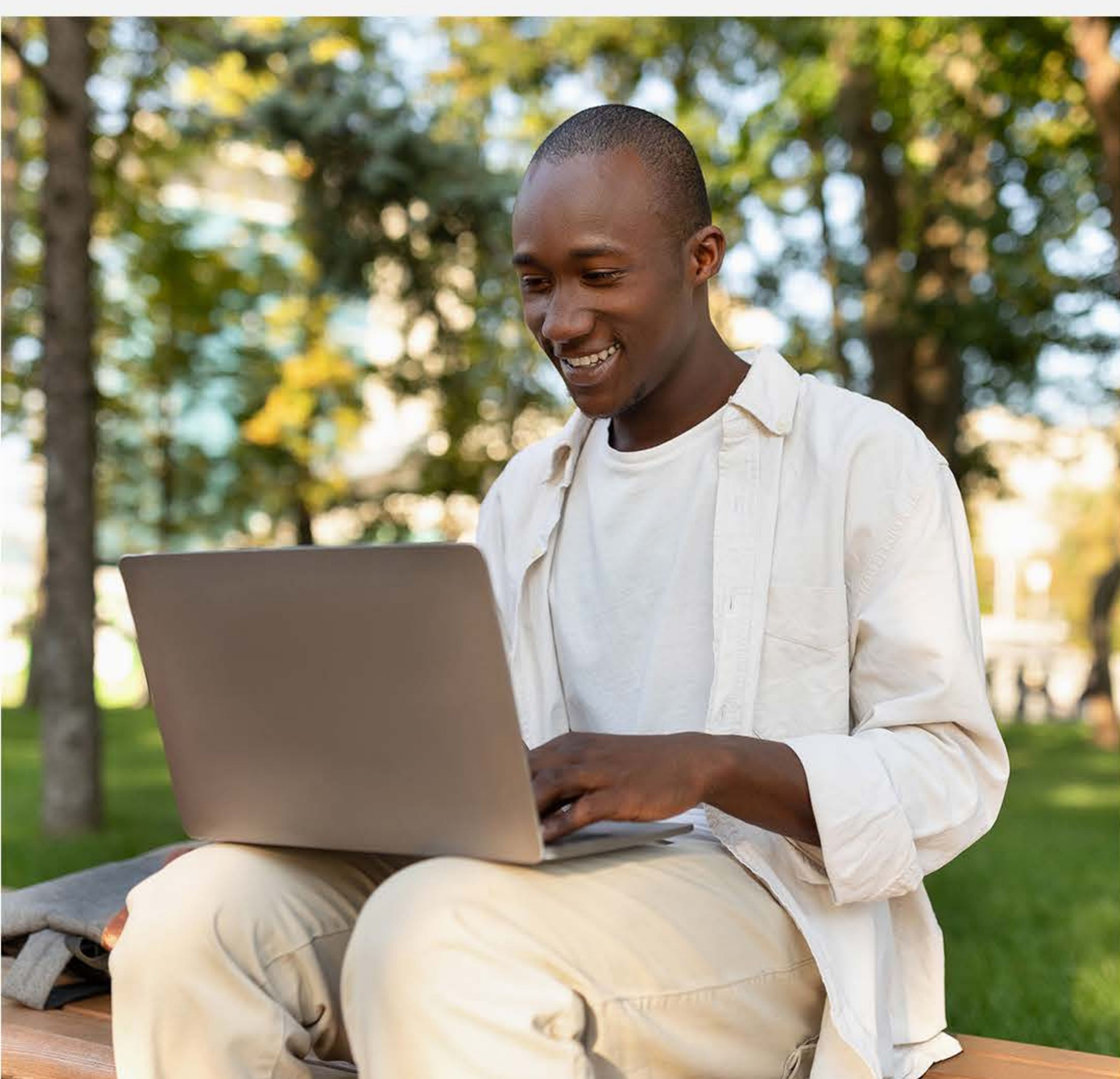

### Required supporting documents for shortlisted applicants (all documents to be sent in a single batch):

Parents, legal guardians, and all income-earning members of a shortlisted applicant's household must provide the following:

- Written consent that they understand that personal information will be requested and given to third parties who will assist TIH with verifying income.
- Completed income and expenditure statement for the applicant's combined household income.
- Certified copies of the following documents in a single batch.
  - Identity document(s).
  - Most recent payslip(s), letter(s) of employment, not older than three months, of each parent or guardian.
  - Proof of income, home loan account statement, and city/town council rates and taxes statement (not older than three months), if parents or guardians are informal traders or hawkers.
  - An official pension slip or bank statement (not older than three months), if parents or guardians receive income in the form of pension/ grant/maintenance/rent/interest from investments.
  - Full academic transcripts AND certificates to date (certified copies).
  - Signed bursary or loan agreement.
  - Proof of household monthly/annual income (maximum household income of R600 000 will be considered).
- Monthly budget, stating income and expenditure.
- Proof of any dependents.
- Tax Invoice stating the tertiary institute's fees.
- Letter of recommendation from a parent or guardian (optional).
- Curriculum vitae (compulsory).
- Face to face interviews will be conducted with shortlisted applicants.

Shortlisted applicants may be required to undergo psychometric and other assessments.
